Peru Launches International Renewable Energy Auction

1. Background

Pursuant to the Regulations on Renewable Energy Electricity Generation, approved by Supreme Decree No. 012-2011-EM, the Supervisory Body for Investment in Energy and Mines ("OSINERGMIN") has called the fourth auction for the supply of electricity generated using renewable energy sources (the so-called "RER auctions") to the National Interconnected Electricity System ("SEIN").

2. Purpose of the Auction

The auction is held is to select renewable energy electricity generation projects for the supply of electricity to the national system. The renewable energy projects will use the following technologies:
