He handles the legal defense of numerous clients in proceedings at the Constitutional Court, Supreme Court, National Appellate Court (*Audiencia Nacional*) and various high courts (*Tribunales Superiores de Justicia*). He provides advice to both public sector entities and private enterprises and individuals in their relations with the public authorities, preparing reports, handling queries and participating in administrative proceedings.

His professional activity includes matters related to fundamental rights and public freedoms, zoning, public domain assets, public property transactions, transparency, public-private partnership, housing and public companies, among others.

He is a member of the Barcelona Bar Association and graduated from Universitat Pompeu Fabra in Barcelona, where he has been studying a PhD program in Law since the 2020-2021 academic year. He participates in a diverse range of lawsuits, both in the administrative phase and also in the judicial review phase: from challenging urban planning instruments, to claims for administrative liability due to COVID-19, including conflicts regarding compliance with administrative agreements, penalty proceedings, management of public services, public levies, etc.

He acts before the Constitutional Court (appeals for protection of constitutional rights and unconstitutionality) and before the Supreme Court (cassation appeals), and also before the various judicial review courts.

To date, he has also taken part in two legislative proceedings, one in central government and the other in the Catalan Parliament.
