He also advised a Spanish airline on the tax treatment and refund of indirect taxes in Mexico. He led the defense against a tax claim in excess of Mex\$200 million, successfully obtaining its annulment. His experience includes preparing requests for constitutional protection against tax reforms, having obtained numerous favorable rulings benefiting his clients.
