Pablo García Castro has been a principal associate in the Restructuring and Insolvency Department of Garrigues since 2022. He holds a law degree from the University of Santiago de Compostela, and studied his last year of his degree at the Robert Schuman University of Strasbourg, France (currently the University of Strasbourg).

## Experience
