Carlos Loaiza-Keel has over 20 years' professional experience in different countries in Taxation, M&A, Corporate Law, Compliance and Management, at both local and international levels.

Throughout his professional career, he has advised multinational groups with investments in Europe and Latin America, participated in some of the most important M&A and corporate restructuring deals taking place on the continent, and handled complex negotiations with the Tax Authorities.

Educated in the University of Navarra and Centro de Estudios Garrigues of Spain, the Austral University of Buenos Aires, the Panamerican University of México, Harvard Law School and Singularity University of the United States of America and the University of Montevideo of Uruguay in Management, Computer Science and Technology, Compliance, Taxation and Corporate Law.

In 2015 he rejoined Garrigues as a Local Partner to participate in its international expansion project in Latin America. He also develops coordination activities in the Taxation Group in Latin America and participates in

the development of technical contents.

Throughout his professional career, Carlos has advised multinational groups with investments in Europe and Latin America, and participated in some of the most important M&A deals taking place on the region, such as the US\$ 3.2 million purchase by the Colombian group SURA of assets of ING throughout Latin America, which was named "Deal of the Year 2011" by the British magazine Latin Lawyer; or the US\$ 400 million purchase by Arauco-Stora in 2009 of the ENCE Group assets in Uruguay, the largest transaction in Uruguay's history to date.
