José María Muñoz is Professor in Commercial Law and partner in Garrigues' Commercial Law and Litigation and Arbitration Departments, having first joined in 2005. He is a specialist on corporate law, commercial contracts, and forensic and arbitration practice in these fields. In corporate law, José María is a proven expert in corporate disputes and their implications during general meetings and board meetings, and in subsequent appeals against corporate resolutions. He also has vast expertise in insurance law, a field in which he has authored numerous publications and handled significant litigation. He has participated in numerous arbitrations (as a lawyer and as an arbitrator), both domestic and international, and accumulates a wide expertise, mainly in those concerning engineering contracts and the implementation of industrial projects. As a corporate lawyer, he has advised a wide variety of operations concerning the purchase and sale of companies or assets (student residences and hotels) for both domestic and foreign clients.

## **Experience**

José María Muñoz has been a partner at Garrigues since 2008. One year earlier, he obtained the Cátedra de Derecho Mercantil (Chair of Commercial Law) at Universidad de Oviedo after obtaining the Habilitación nacional para Catedrático de Universidad (National Qualification for University Professor) in a competitive procedure.

By his training, José María is a member of the litigation and arbitration department, being involved in a wide range of commercial litigation proceedings, combining his practice in both corporate and contract law.

In corporate law, José María is Secretary non-director for several business groups and particularly experienced in the assistance and issues of corporate bodies as well as good corporate governance, including family-owned companies. He has been advising for years in many corporate conflicts, mainly in family companies, but also in quoted companies, and has worked particularly on the rights and obligations of the directors and on General Meeting questions. He has also been involved in numerous M&A transactions, advising both buyer

and seller, as well as in the acquisition of assets, mainly real estate (student residences and hotels).

He is also a renowned expert in insurance contract and retirement plan law, as well as in insurance mediation, a subject in which he has authored many scientific publications. In this area, he has provided legal advice to several Spanish and foreign insurance companies, as well as to brokerage firms and insurance-banking operators, and assumed the management of relevant legal proceedings. He is also Director of the Spanish Insurance Journal, Spanish representative on the Board of AIDA-Europe (International Association of Insurance Law) and member of the Board of SEAIDA, and arbitrator of the Spanish Insurance Arbitration Court. One of the co-authors of the Draft Bill of the Brazilian Insurance Contract Law, and subsequently summoned by the Brazilian Congress in order to report it to the legislative committee in charge handling it (2012).

He has been counsel in several insolvency proceedings and refinancing operations. His expertise explains why he was a consultant to the Inter-American Development Bank for the reform of bankruptcy law in Guatemala (2010) and Mexico (2013).
