PUBLIC HOLIDAY CODES:

- ◆ Irreplaceable National Public Holiday.
- ◆◆ National Public Holiday in respect of which the power of replacement has not been exercised.
- ◆◆◆ Public Holiday of the Autonomous Community.

In the Canary Islands Autonomous Community, Decree 74/2013, of July 18, establishing the Calendar of Public Holidays of Canary Islands Autonomous Community for year 2014 (Official Gazette of the Canary Islands of July 29, 2013) establishes: At the islands of El Hierro, Fuerteventura, Gran Canaria, La Gomera, Lanzarote, La Palma and Tenerife, the following days shall also be public holidays: On El Hierro: September 24, Our Lady of the Kings; on Fuerteventura: September 19, Our Lady of the Rock; on Gran Canaria: September 8, Our Lady of the Pine; on La Gomera: October 6, Our Lady of Guadalupe; on Lanzarote: September 15, Holy Virgin of Sorrows, Our Lady of the Volcanos; on La Palma: August 5, Our Lady of the Snow; on Tenerife: February 3, Monday after the Candelaria Holy Virgin Festivity.

In Cataluña Autonomous Community, Order EMO/202/2013, of August 22, establishing the Official Calendar of Public Holidays for year 2014 (Official Diary of Cataluña Autonomous Community of August 30, 2013) establishes:

"Of the thirteen aforementioned public holidays one, which may be January 6 (Epiphany), April 21 (Holy Monday), June 24 (Saint John) or December 26 (Saint Stephan), which will be recoverable. The other twelve will be remunerated and non-recoverable".
